

# Golden Apple Awards

Nunley, Chairman, is pleased to announce that Better Living Building Supply & Better Living Furniture is, once again, sponsoring the **2018-2019 Annual Golden Apple Awards Ceremony** for outstanding teachers in our school systems. These awards are presented to faculty members from the public and private schools in Albemarle County and City of Charlottesville, including CATEC. Eligible private schools are those that are current members of the Virginia Association of Independent Schools (VAIS).

The Golden Apple Award is a means of selecting and honoring some of our outstanding teachers. Teachers are most important in nurturing our children's inquisitive minds and preparing them for the challenges of the future.

## **The Golden Apple Award**

One winner will be selected from each school. Award recipients will receive a Golden Apple, as well as gift certificates from local businesses. As a "Golden Apple" teacher, each recipient is eligible to receive a \$1,000 Golden Apple Grant. Grants will be awarded to eight candidates: three elementary, two middle, and two high school candidates, and one from the schools that are members of the VAIS. The grant award can be used for classroom materials or to support the recipient's continued professional development. Golden Apple Award recipients will be announced in May.

## **Eligibility**

Candidates are faculty members at any level (pre-school through grade twelve) and in any discipline. Candidates for this award have demonstrated excellence in teaching and involvement in the community outside the school. For more information, see Nomination Criteria. Golden Apple Award recipients who received this award within the past three years are not eligible for nomination.

## **Nomination Criteria**

The nominee exhibits the following characteristics:

- Creates a love of learning in students of all abilities and backgrounds.
- Stimulates thought and provokes student dialogue.
- Challenges students to reach high standards and expectations.
- Understands the needs of students individually and collectively, and meets those needs with determination, enthusiasm and imagination.
- Involves families in the education process.

### **Nomination Process**

1. Based on the nomination criteria, candidates may be nominated for the Golden Apple Award by colleagues, students, and/or community members. Deadline to submit a nomination: **Monday, February 4, 2019**
2. Nominations must be forwarded to and signed by the school principal for advancement to the selection process (signature obtained in “Part 2” of the nomination form).

### **Selection Process**

1. The Selection Committee reviews the nominations and qualifies them for the selection process.
2. One candidate from each school and level is selected as the Golden Apple Award recipient.
3. Award recipients receive a *Golden Apple*, as well as gift certificates from local businesses. As a *Golden Apple* teacher, each candidate is then eligible to receive a \$1,000 Grant. Grants are awarded to eight candidates: three elementary, two middle and two high school candidates of the public schools in Albemarle County and City of Charlottesville and CATEC, and one from the schools that are members of the Virginia Association of Independent Schools (VAIS). The grant award can be used for classroom materials or to support the recipient’s continued professional development. Golden Apple Award winners are announced in May.

### **Award Ceremony**

Golden Apple Award recipients will be invited to a reception in their honor on **Thursday, May 16, 2019 from 4-6pm**, in the *Lane Auditorium* at the *County Office Building – McIntire*. Refreshments will be served beginning at 4:00 p.m., and the ceremony will start promptly at 4:30 p.m. Golden Apple *Grant* recipients will be selected and announced during the ceremony on **May 16<sup>th</sup>**.
