## SOL Testing FAQ

1) If a student comes to our school from outside the Division just before our window opens, are we required to test them? Students transferring in before your window opens must test.

#### 2) Which tests may we schedule to take over two days?

Elementary Schools may choose to do any or all Reading and Math SOL tests over 2 days.

#### 3) Can a student take the paper form of the test instead of testing online?

All students are required to take the online version of the SOL tests with the exception of students who meet one of the criteria below:

- The accommodation specified in the student's IEP, 504 Plan, or LEP Plan requires a paper test. Accommodations requiring a paper test include Largeprint, Braille test, and a flexible schedule that **requires** multiple testing sessions over 2 or more days.
- Student has a documented medical condition, such as seizure disorder, where exposure to a computer will aggravate the condition.
- Student's eligibility for paper tests has been established using the *Documentation of Need for Paper/Pencil Standards of Learning Assessment* form. The form documents the use of paper tests is intended only to provide access to the SOL assessments for the following students:

--Students with disabilities who require other accommodations that necessitate a paper test

--Students with medical conditions that render them unable to take an online test

#### 4) Are students who fail a test allowed to retake the test?

- Students taking grades 3-8 tests may retest if the original score is between 375 and 399 **OR** fall below 375 and have an extenuating circumstance which warrants a retest. Extenuating circumstance retakes require Superintendent approval. Remediation is not required for retakes.
- Students taking high school classes may retest in the same administration if they score between a 375 and a 399 and need the verified credit for that class. Remediation is not required to take an expedited retake
  - --Students not meeting the 375 cut-off may retest if there are extenuating circumstances that warrant a retest.
  - -- Generally, students trying to graduate in the current year will be given multiple opportunities during each administration to retest regardless of scores. Remediation is required between the 2<sup>nd</sup> and 3<sup>rd</sup> attempt.

#### 5) When are scores available and when can they be sent home?

- Online scores of equated tests are usually available to STCs in a matter of minutes after the test is submitted. Scores from unequated (new) forms of the test take anywhere from a few days to a couple of weeks to come through.
- Schools decide on an individual basis when and how to share scores with students and send reports home

#### 6) When will scores be available in PowerSchool:

- Fall Writing by January 31
  - Fall Non-Writing by March 31
- Spring Writing and Non-Writing by June 30

## **Pearson/Computer Preparations Before Testing**

#### Print Test Tickets - no more than 96 hours (4 days) prior to the test session start date. Must be stored in a secure location until needed.

- 1) Log into Pearson and click Sessions under Testing.
- 2) Check the name of your session
- 3) Click Task then choose Shows Students in Sessions & Controls Sessions.
- 4) Highlight session name, check student names.
- 5) Click **Resources** and print all or selected for this session.

#### Print Seal Code - no more than 96 hours (4 days) prior to the test session start date. Must be stored in a secure location until needed.

- Every Grade 3-5 Reading and Grade 3-7 Mathematics tests require a **Seal Code**. You will also need to print the Seal Code sheet found under the **Resources** menu.
- If you are conducting any <u>Read Aloud</u> sessions online (not to be confused with <u>Audio</u> sessions), you will also need to print a **Proctor Authorizations** ticket, also found in the **Authorizations** menu.

#### Proctor Cache Tests - morning of testing or no earlier than 24 hours prior to the start of the division's test window.

- 1) Log into Pearson and click Sessions under Testing.
- 2) Check the name of your session.
- 3) Click Task and choose the Precaching Test Content process.

#### **Start Session – morning of testing**

- 1. Check the session name under **Testing**.
- 2. Click Task then choose Shows Students in Sessions & Controls Sessions.
- 3. Highlight session name, check student names, click **Prepare**, and click **Start**.

#### **Getting Computers Ready – morning of testing**

Computers should be logged into TestNav before students arrive. User Name: sol Password: test

#### Stop Session or Lock the Test at the end of the testing session/day – click Stop (where Start was)

You will only be able to stop the session if <u>all</u> students in that session are in complete status. Any students not in completed status must be removed from the session and then put in make-up session for later testing or use the lock feature and reopen when you need to test.

L he Virginia Board of Education is revising its accreditation standards to provide a more

comprehensive view of school quality while encouraging continuous improvement for all schools and placing increased emphasis on closing achievement gaps. School accreditation ratings for the 2018-2019 school year will be the first to reflect this new approach to accountability.

### **School Quality Indicators**

The revised accreditation standards measure performance on multiple school-quality indicators, not just on overall student achievement on state tests.

#### Elementary and middle schools are evaluated on the following indicators:

- Overall proficiency and growth in English reading/writing achievement (including progress of English learners toward English-language proficiency)
- Overall proficiency and growth in mathematics
- Overall proficiency in science
- English achievement gaps among student groups
- Mathematics achievement gaps among student groups
- Absenteeism

#### High schools are evaluated on the following school-quality indicators:

- Overall proficiency in English reading/writing and progress of English learners toward English-language proficiency
- Overall proficiency in mathematics
- Overall proficiency in science
- English achievement gaps among student groups
- Mathematics achievement gaps among student groups
- Graduation and completion
- Dropout rate
- Absenteeism
- College, career and civic readiness (effective 2021-2022)

### **Performance Levels**

Performance on each school-quality indicator is rated at one of three levels:

LEVEL ONE: Meets or exceeds standard or sufficient improvement

LEVEL TWO: Near standard or making sufficient improvement

LEVEL THREE: Below standard

A nonpassing student is considered to have demonstrated sufficient growth to be included in the combined rate if the student improved by at least one performance level, as illustrated by the examples shown in the following charts.
